# **Manager Comments**

The regional GCC markets continued to outperform the developed markets in April as US stocks closed out their worst month in years. Investors climate largely being impacted by the US GDP decline of 1.4% and US Fed's aggressive rate hikes and monetary tightening, worsening inflation, COVID lockdowns in China and the continuing war in Ukraine. Brent ended at \$108.36, almost flattish for the month, but remained very volatile during the month.

Most GCC markets ended the month on a positive note except for Oman and Bahrain, which ended with modest losses of 1.1% and 0.8%, respectively. Dubai market led the pack with a 5.5% gain, followed by Saudi with 4.9% rise. Kuwait premier market gained 2.7% and Abu Dhabi ended with gains of 1.3%. Qatar market stood volatile during the month and ended with modest 0.4% gains, after giving away most of its intra month gains. The S&P GCC composite index gained 2.81%

The NBO GCC Fund performance during the month was impacted by USA allocation and change in accounting of NAV, to reflect the impact of performance fees. On a YTD basis, the fund has reported gains of 16.02%.



#### **Sector Allocation**


